# Reconciliation is at the core of shared prosperity in BC forestry

First Nations play a vital role in land stewardship in BC. Indigenous ownership of forest management and manufacturing operations can also create significant social, economic and employment benefits to Indigenous communities. The BC Council of Forest Industries (COFI) and its members are committed to upholding and implementing the principles of BC's Declaration on the Rights of Indigenous Peoples Act (DRIPA) through meaningful relationships, collaborative opportunities, partnerships, and increased revenue sharing.

#### Equity participation

In 2023, the Tlowitsis, We Wai Kai, Wei Wai Kum and K'ómoks First Nations signed an historic agreement with Western Forest Products for the Nations to acquire a 34% interest in a newly formed Limited Partnership known as La-kwa sa muqw or 'the wood of four' on Vancouver Island.



#### Bio-Economy Partnerships

In Prince George, Arbios Biotech, a joint venture of Canfor and Licella, will use cuttingedge technology to convert wood residues and biomass into renewable biofuels. Arbios and Lheidli T'enneh First Nation are working in close partnership to develop the renewable biofuels facility, which was named Arbios Biotech Chuntoh Ghuna, meaning "The Forest Lives".

#### Value-Added Partnerships

Through the Forest Enhancement Society of BC, Kruger Products is collaborating with Simpcw First Nation and Arrow City Fibre to utilize wildfire salvage and slash pile wood at the Kamloops pulp mill. This partnership increases sustainability and local participation in the forest-based economy by using wood that would otherwise not be economically feasible.



### Shared Values

Forest Landscape Plans (FLPs) play a key role in advancing sustainable forest management practices in BC. These plans prioritize inclusive decision-making, ensuring alignment with DRIPA and incorporating social and Indigenous values in forestry planning. By integrating carbon and wildfire science with traditional ecological knowledge, FLPs promote ecosystem resilience and sustainable land use practices across the province.
